

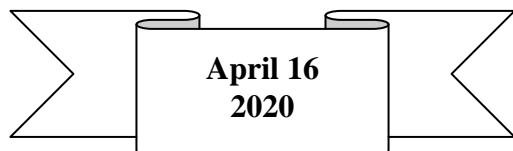

REPORTS FORMATION REQUIREMENTS

Accepted materials are up to 2 pages A5 typed in Microsoft Word as a computer file with the extension * doc or * docx. Times New Roman Cyr font 10. The line spacing is single. Paragraph - 0.5 cm. Fields on all sides are 1.5 cm. Rubrication of theses must contain following data:

- initials and surname of the author(s), name of the organization where the author(s) works (Times New Roman Cyr 9, right alignment);

- thesis title (capital letters), (Times New Roman Cyr 9, center alignment);

- main content of thesis;

- references (optional).

- Students must indicate the supervisor (at the end of the thesis).

Filenames must correspond with authors surname. For example: Petrenko_theses report, Petrenko_application.

Author is responsible for the quality and content of thesis.

Working language of conference:

Ukrainian, English, Russian and Polish.

Language of thesis – English.

Forms of participation:

- full-time: report (up to 10 minutes);
message (up to 5 minutes);

- remote.

Theses will be published in the collection of conference materials and sent to participants' e-mails by May 20, 2020.
