Structure and requirements for abstracts

Materials of 1-3 pages, formatted in A5 format and typed in MS Word editor are accepted for printing in the form of a computer file with the extension *doc. or *docx. Times New Roman Cyr 10 font. Line spacing - single. File size - up to 100 KB. Margins on all sides of 1.5 cm. Paragraph indent - 0.5 cm. The rubric of abstracts should contain the following data: initials and surname of the author and co-authors, name of the organization where the author (s) works or studies (right-aligned); title of abstracts (capital letters, center alignment); presentation of abstracts; bibliography in accordance with current requirements (optional).
